This contract signed this ____ Day of _____ 201____, is the arena operators agreement with the North State Barrel Racing Association, and by the signing of this contract, the operators agree to conduct all NSBRA approved barrel races in accordance to the guidelines listed below. In the event the arena owner is not the arena operator, both signatures are required.

Association, here-in-after referred to as "NSBRA". By the signing of this contact, the Host agrees to the following:

1. Host must be a member in good standing of NSBRA or pay a \$30 annual associate membership fee prior to sanctioning or co-sanctioning races.
2. A standard \$30.00 entry fee will be charged per entrant at NSBRA open barrel races (no money added jackpots). If the race has an Office/Arena fee the fee must be posted in the details on the NSBRA calendar. If there is no Office/Arena fee posted in the details on the NSBRA calendar then the payout will be expected from the posted entry fee. A standard payout sheet is available on the official NSBRA website at www.nsbra.com.
3. Time only runs should be offered at \$5.00.
4. Recap form and Membership forms are available for the arena operator to print out on the official NSBRA website at www.nsbra.com
5. Race results, Recap sheet, and Membership forms will be returned to NSBRA office within 10 days of the race, along with NSBRA sanction fees. Sanction fees are \$3 per entry. ATTENTION: Please do not send cash. Make checks payable to NSBRA. Per NSBRA rule 8.1.14, no contestant checks may be used to pay NSBRA fees.
6. All NSBRA barrel races must be approved by the NSBRA and on the NSBRA calendar for points to be awarded to the members. You must have your jackpots scheduled with the NSBRA Arena Director a minimum of 7 days prior to the race.
7. If your jackpot is not on the official NSBRA calendar a minimum of 7 days, points for the jackpot will not count.
8. NSBRA provides a Million dollar liability insurance policy, with additional million dollar liability insurance available for \$20.00. Please request additional insurance by contacting NSBRA.
9. A standard course should be set whenever possible. Standard course guidelines are available in the NSBRA bylaws and Rulebook at www.nsbra.com
10. It is the responsibility of the arena operator to have a copy of the NSBRA rulebook at all races and follow NSBRA sanctioned arena rules and Primary arena operator rules accordingly. The Bylaws and Rulebook are available to print at www.nsbra.com.

Arena owners and arena operators, by the signing of the contract, agree to hold harmless NSBRA for any damages or liability that may occur in or out of the arena at any approved NSBRA barrel race.
