- **FUTURITY-** PLEASE ATTACH A COPY OF HORSE SPAPERS. Times carried from first go of open. All futurity entries must be 5 years old or younger. The horse may have never competed for money, prizes, or points anytime before November 15 of the previous year
- **YOUTH- 18 AND UNDER AS OF January 1, 2022.** You may run or carry this class from 1st go of open. Buckles to division winners in all 5d's
- Please Mark C/O (carry over)- Must run in the open to carry over
- Refunds/vet/med outs are subject to terms and approval. Any refunds are subject to a 30% fee plus office fee.

- **Novice-Based on horse. Horses not to have won over \$500**
